UBB Interlease finances the purchase of passenger cars and light commercial vehicles, production equipment, transportation vehicles, construction and agricultural equipment for almost all sectors of the Bulgarian economy and the public sector. The main forms of the offered crediting are financial and operational leasing in all their varieties, known in the sphere.



The company has successfully implemented the Business Intelligence project, based on the Qlik Sense platform, through which it digitizes its reporting in the "New Business" and "Portfolio" sections. Therefore, it implements a unified, flexible and dynamic information and reporting system that automates reporting.

The project management uses a hybrid approach, which combines the traditional approach to planning and defining the scope and budget, using a flexible approach to implementation. Thus, the final product is delivered in four iterations, as after each UBB Interlease it has prepared analyzes and reports. This allows key users in the company to quickly test and give feedback on the delivered scope components, as well as to contribute to the full implementation of the solution in just six months.

The new BI platform automates the company reporting by providing reports, analyzes, graphical and static visualizations, related to sales reporting. The 22 developed dashboards help to monitor: the fulfillment of the set goals at agent level; the market share of the company; active customers; top customers and deals; top suppliers; cross-selling; insured assets, premiums and commissions; business lines profitability analysis; as well as the profitability of leasing administrators, agents and mediators.

Aggregate data is available in a single application. It can be viewed at different levels and sections, enabling quality and purity control. Updating it twice a day allows you to maintain a realistic picture of the business state and development.

The system itself has a user-friendly and intuitive interface and can be accessed from any device. At the same time, thanks to the online access, users can prepare reports and check the entered data from anywhere and at any time.

BI software has been successfully integrated with the company core lease management system (contracts and applications), accounting system and related external Excel reports that support data for planned purposes. When asset leasing processing starts in the main system, everything is reflected online in the BI system. This makes it possible to make continuous comparisons with budgets, goals and key indicators.

The business analysis system sets out rules for managing end-user access by level and position within the organization.
